



Hygiene concept for the realization of the Beach Tennis Open Saarlouis 2021

München/Saarlouis, 22.07.2021

On the

Kleinen Markt, Saarlouis
(hereinafter referred to as VENUE)

as well as on the facilities

TSV Steinrausch, TV Griesborn and TuS Wadgassen
(hereinafter referred to as ASSOCIATIONS)

The Beach Tennis Open Saarlouis will take place from August 25-29, 2021. These consist of the ITF World Tour Sand Series Tournament and the German Beach Tennis Championships.

The following hygiene concept will be created and implemented for this event:

§1 Basis

The basis are the recommendations for competitive and mass sports from the current regulation of the state government of Saarland from 09.07.2021. Here, sports competitions and sports competitions are again permitted. This regulation can change at any time until the event. The currently valid regulation will then apply. The following is to be considered at present:

1. Competitive sports outside are again permitted without restriction of persons.
2. Hygiene regulations in accordance with the Infection Protection Act must be kept.
3. A valid hygiene concept must be drawn up.
4. A person must be appointed who is responsible for compliance with the rules.

In addition, the event takes the official recommendations on corona protection of the DTB and its state associations as a basis for the implementation of the event. The German Beach Tennis Championships and the ITF Beach Tennis Tournament are outdoor sports competitions with a total of approximately 300 players over five days at 4 different venues. This leads to an equalization of the event compared to previous years.

§2 Implementation

1. Registration procedure

All players must register in advance in writing and bindingly for participation in the event. All contact details such as surname, first name, date of birth, address, telephone number and email address must be provided. The organizer reserves the right to refuse registrations without giving reasons.

2. Positive tested / symptoms

Players who have tested positive or have symptoms at the time of the event are not allowed to participate in the competition or to enter the facilities of VENUE or the ASSOCIATIONS.

At the sign in at the tournament office, players must sign to confirm that they are not currently tested positive, have no symptoms, nor have been in contact with anyone who has tested positive in the two weeks prior to the event.

3. Corona tests

Corona testing is mandatory for all players on a daily basis. The test must not be older than 24 hours when entering the facility. The test obligation is to be carried out on one's own responsibility.

There are 3 testing facilities in the immediate vicinity of the Kleiner Markt. It is not necessary to book an appointment. One test per person and day is free of charge there.

In exceptional cases, a certain number of tests are available at the Event Office, which must then be paid for there with Euro 5,- each. Those who test positive will not be allowed to participate and will have to undergo a PCR test immediately.

Negative tested persons are equal to recovered or fully vaccinated persons. Proof of this must be shown when entering the VENUE or the ASSOCIATIONS.

4. Distance rules

The distance rules currently in force in the Saarland must be kept. Excluded from this are the usual and necessary procedures and movements for the sport.

5. Mask obligation

Within the VENUE and the ASSOCIATIONS FFP2-mask is mandatory, if the minimum distance is not guaranteed, as well as when entering, leaving and staying in the tournament office and in all closed rooms on the VENUE and the ASSOCIATIONS. Mask must also be worn when entering the Players' Lounge. This can be removed at the seat.

6. Disinfection

There are several facilities for disinfection on the VENUE and the ASSOCIATIONS. Players are encouraged to use these on a regular basis.

There will be regular cleaning of the Players' Lounge, restrooms and publicly accessible areas.

7. Spectators

Basically, spectators are allowed at the competition. The maximum number of players and spectators on the course at the same time is determined by the current regulation of the Saarland state government.

The Centre Court and the other courts on the Small Market are seated for spectators. Spectators will be assigned a fixed seat upon entering the Centre Court. In addition, standing-room areas are available, which is limited to a total of 200 persons in accordance with the current Corona regulations. The spacing rule applies on all courts.

All spectators entering the spectator areas of the courts must register via the Luca app or Corona app for contact tracking.

PLANB shall carefully prepare and retain all registrations for required follow-up and, if necessary, hand them over to the health authorities. Applicable data protection rules must be complied with.

PLAN B shall ensure compliance with these rules through organizational measures.

8. ID cards and wristbands

Players, coaches and staff of the organization are identified by badges and wristbands.

9. Other measures of the organizer

PLANB places information signs on the VENUE facility and in the clubs and ensures compliance with the hygiene rules through personnel and organizational measures.
